Before the camporee: Review orienteering (taking a bearing, measuring your paces), how to make a stretcher, square lashing (to make a ladder), one-handed bowline, all seven basic Scout knots, the bandages for Frist Class requirement 7a, basic fire building, and the 10 essentials.

Personal gear to bring: Each scout will need to bring a daypack that includes the ten essentials (especailly a full water bottle), a small bottle of hand sanitizer, and a mask for use when not able to maintain six feet of distance from others.

Patrol Size: between 5 and 9 Scouts

Instruction: classes will be provided on Saturday between breakfast and lunch to teach the skills needed on the course. The classes will be: orienteering, how to make a stretcher, suare lashing/one-handed bowline, all seven basic Scout knots, bandages, basic fire building. Let us know at the Scoutmaster/SPL meeting which specific scouts would like to take which classes.

Campfire: Represent your troop by bringing your best skit and making everyone laugh. Let us know which skit you'll be doing at the Scoutmaster/SPL meeting.

Scoutmaster/SPL Meeting: Friday night at 9:00. We'll let you know at check in where the meeting will be.

Camporee Fees: Scouts/Leaders: \$12.00

Registration: Troop registration and payment must be received no later than March 5th.

Parking: Gear may be driven by vehicles to the campsites. The troop trailer and one vehicle attached to the trailer are to be the only vehicles left in the campsite area. All other vehicles will park in the designated parking lot.

Scoutmaster/SPL Meeting: Friday night at 9:00. We'll let you know at check in where the meeting will be.

Medical Forms: Each troop will ensure that they have a copy of a current BSA Medical Form Parts A and B (signed by a parent, for the Scout) for each participant. These will be kept by the Scoutmaster for their reference and for use by the Camporee Medic/and or Medical Staff in the event of an emergency.

COVID Waivers and Protocol: A COVID waiver form will be required for each Scout (must be signed by a parent or legal guardian) and for each adult. These will be required to be turned in at registration on Friday night. Before you arrive at camp, we ask that each troop check with each scout to see if they have experienced any COVID symptoms in the previous 48 hours or if they have been exposed to anyone who displayed symptoms or tested positive in the last week. If they have, then we ask that the person not attend the camporee. Please ask each Scout to bring a small bottle of hand sanitizer for use during the weekend. A mask will be required anytime a person cannot maintain six feet of social distance unless eating or drinking, as per guidance from the State Health Officer.

Appendix (We know your're not going to read this but we're going to expect you to know this stuff anyway)

CAMPOREE POLICIES:

1. Scouts will be required to wear their Class "A" uniform to the Camporee Flag Ceremony and Sunday religious ceremony.
2. Ecunchatee District will follow the principles of Leave No Trace and Outdoor Ethics. Fires are to be placed in an above ground fire pit that you bring with you.
3. Bring trash bags to remove your unit's trash.
4. Sign in and out at the registration area when arriving or leaving during the Camporee.
5. ***Each scout should have a day pack with their 10 scout essentials which includes a personal First Aid Kit and sun protection with them at all times. Check Boy Scout Handbook for items.***
6. Park vehicles in the parking area. Troop trailers will be allowed at your camp area.
7. Do not use flame producing equipment inside tents, per BSA policy.
8. Pocket knives whose blades do not exceed the width of palm of carrier's hand are allowed. Pocket knives exceeding those dimensions or non-folding sheath-type knives are not allowed at camporee.
9. At least two adults per unit must be present during the entire camporee.
10. Each Scout must bring Totin' chip and Firem'n Chit if they wish to carry a pocket knife, use tools and/or light a fire.
11. Bring your own filled water containers. Additional water is available at Camporee Site.
12. After lights out, campers and leaders are not to enter other campsites or disturb other patrols with lights, loud noise, etc.
